

# **End User License Agreement (EULA)**

Bright Arboretum - Effective September 24, 2024

This End User License Agreement ("EULA") governs the relationship between you and Bright IT GmbH ("Bright IT," "we," "us," or "our") concerning your use of the Bright Arboretum software and related services (the "Service"). By installing the Service or any updates, you agree to be bound by this License Agreement.

#### License Grant

Subject to this Agreement, Bright IT grants you a non-transferable, non-exclusive license to use Arboretum solely for your internal business operations, in accordance with this EULA.

### Maintenance and Support

Bright IT is not obligated to provide ongoing maintenance or technical support for Arboretum unless otherwise agreed in writing. However, Bright IT may, at its discretion, offer support packages or paid support services for users.
